I. Information about the issuer:

FORT S.A. (FORT / The Company or The Issuer) with registered office in Bucharest, Str. Sergeant Ion Nuțu no. 44, ONE Cotroceni Park, building A & building B, 4th floor, district 5, Telephone: (+4021)5271600, Unique registration code: RO34836770, Order number in the Trade Register: J40/9427/2015, Share capital: 1,120,928.60 ron, company listed on the multilateral trading system, the AeRO market, managed by the Bucharest Stock Exchange as market operator, under the trading symbol 4RT.

II. Decisions related to the allocation of free shares

Through EGMS Decision no. 02nd July 2024 the shareholders of FORT approved the increase of the share capital by the amount of 1,019,026 ron by issuing a number of 10,190,260 ordinary shares with a face value of 0.1 ron/share, assigned for the benefit of the shareholders registered in the shareholders' register held by the Central Depository, on the registration date set by EGMS, respectively on 17th September 2024. The distribution of the newly issued shares will be made in the proportion of 10 (ten) free shares for every 1 share held on the registration date. If, in the case of a shareholder, the proportion 10:1 leads to a number of shares that is not a natural number, the new number of shares to be received is calculated by rounding to the lower natural number. The company will compensate the shareholders for the resulting fractions through the Central Depository. The increase of the share capital will be achieved by capitalizing the issue premiums in the amount of 1,019,026 ron. The approval decision, as well as the new Incorporation Act with the new coordinates of the increased share capital and also the new number of shares, were registered in the Trade Register. The issuer received the registration certificate no. 2020494/30.07.2024 from the Trade Register. The new coordinates of the share capital and the number of shares were registered in the FSA records. The FSA issued the registration certificate for financial instruments – shares – AC-5924-2.

III. The reasons for assigning shares

The free shares allocation is part of the company's strategy to increase the liquidity of 4RT shares on the AeRO market. At the same time, the increase of the share capital from the amount of RON101,902.60 to the amount of RON1,120,928.60 by incorporation in the share capital of a part of the issue premiums aims to strengthen the share capital structure.
